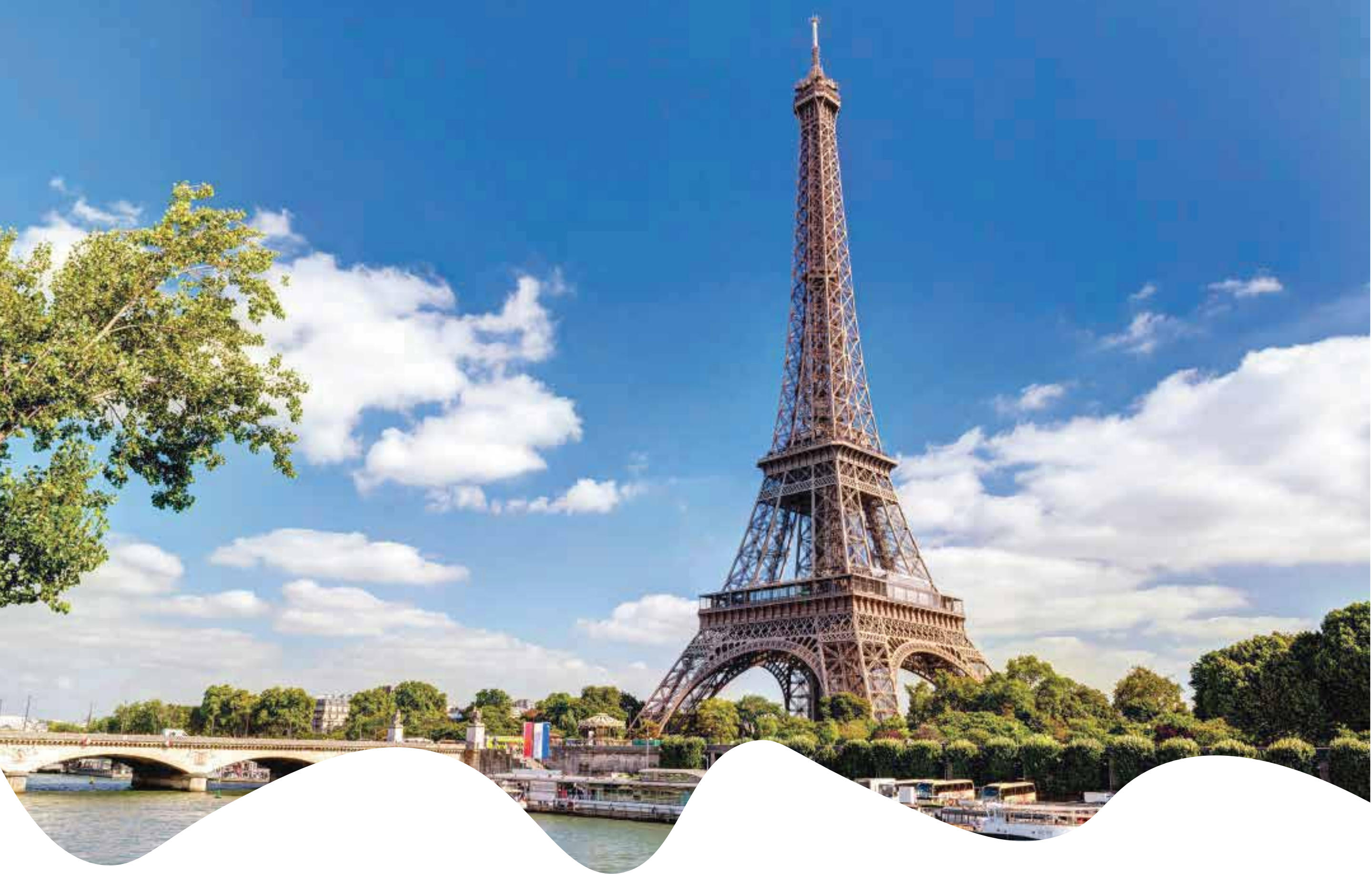

- Any add-on sightseeing/ sightseeing done twice /activities along with transfers other than mentioned in the tour program and anything not specifically mentioned in Tour Cost inclusions.
- In accordance with the provisions of Section 206C(1G) of the Income Tax Act, 1961 and the latest amendments introduced under the Finance Act, 2026 (effective from 1 April 2026), Tax Collected at Source (TCS) is applicable on the purchase of Overseas Tour Program Packages. As per the revised framework, a uniform flat TCS rate of 2% shall be collected on the total package value from the first rupee onwards, replacing the earlier slab-based structure. The TCS amount collected is not an additional cost to the customer and may be claimed as credit against the total income tax liability or as a refund while filing the Income Tax Return (ITR) for the relevant financial year.
- Customers are requested to provide a valid PAN at the time of booking to ensure proper compliance and seamless reflection of tax credits in Form 26AS / AIS. In cases where PAN is not furnished, a higher TCS rate of 5% shall be applicable in accordance with the provisions of Section 206CC of the Income Tax Act.

TERMS & CONDITIONS

- A person up to 11 years is considered a child and 12 years and above as an adult, International Check in time in hotels are 15.00 Hrs and Check Out Time is 11.00 Hrs
- Visa Fee and Flight Ticket is Non-Refundable under any circumstances
- Once group airline ticket is issued no changes accepted and no cancellation allowed
- Coach can park the vehicle only at the desired parking space not on any other free space. Heavy penalty applicable if we didn't park at the desired parking space. So that the coach cannot park near to the restaurant or near to the attractions at all time, in that case we have to walk few meters to reach the desired place
- Refund is not entertained for any expense incurred by the passengers due to circumstances beyond our control such as flight cancellations delays , accident of any nature, bad weather, natural calamities, Medical Evacuation, Supplier policies, visa rejection and Visa Delay.etc.
- If the Passenger missed their flights , the entire ticket got now show and the ticket is non refundable and the new air tickets has to be taken by the passenger themselves.
- Incase of passenger with a granted visa , denying to travel or cancelling his/her own tour on account of Visa Rejection caused to the Co Passenger or his/her companion, Cancellation charges is applicable and it is the sole discretion of the concerned counsulate.
- The company reserves the right to postpone or cancel any of the tours advertised without assigning any reason.
- In some unavoidable circumstances, the company reserves the right to change / modify / vary and alter the tour itinerary, if it becomes necessary. In such changes, compensations or claim for refund by the passengers will not be entertained by the company for limitation and also for the non- availability of certain services with entry tickets, restaurants, sightseeing, shopping etc. even though included in tour itinerary.
- For Single Passenger travelling without family have to share a room either on twin or triple sharing basis (Roll away bed) depending on the booking. If we do not have another single passenger to share the room, Single Supplement with additional cost is applicable.
In all the hotels the rooms booked are Double or Twin Room basis. Only Two Triple Accommodation can be booked in a group as per the Hotel policies.
- Packed meal will be provided one or two times according to the situation demands.
- The pricing of the tour quoted is calculated as per the ROE rates prevailing at the time of quoting it
- The company reserves the right to change the tariff in the event of modification/alteration/change/variation in the said rates before the date of departure
- Tour tariff is based on departure from Cochin, unless specifically mentioned. Tourists boarding flights at places other than Cochin have to pay the entire airfare difference and bear and pay any other additional expenses including airport transfers, hotel stay etc. on that account.
- Tour cost is based on minimum 30 passengers travelling together in the group. If there is a drastic fall in the number, then the offered tour cost, meal plan, vehicle and other services may change accordingly and the difference amount has to be borne by the passenger.
- As a Travel House / Tour Operator, the company does not have any control over Airlines, Coach Companies, Shipping Companies, Hotels, Local Transport or any other facilities, provided by the third parties. The company is not responsible for the delays or deficiencies in the services provided by outside agencies. Also please note that the company does not have any control on schedules of opening and closing timings of the tourist attractions.
- The guests are requested to collect Air tickets, Visas and other travel documents from the respective offices of Sky Days Tours and Travels , only after making the full payment, from where they have booked their tour. No tickets will be sent by courier.
- Any damage caused to the hotel rooms or coach during your stay shall be payable by the passengers. Sky Days Tours and Travels will not be held responsibility for the same.
- There are no refunds for any services, i.e. meals, sightseeing's, flight delay or cancellation of flight etc. not utilized on the tour.
- Any disputes arising in respect of the tour shall be subject to Eranakulam Jurisdiction.
- Any tour package cancelled under Force majeure situation ie; tour packages cancelled or unable to operate on account of reasons beyond our control (Eg: Pandemic situation), the amount received from the customers after deducting all expenses which are not recoverable in any manner will be kept in customer credit (Credit Shell) and provide the facility to utilize the same credit note value towards booking of future tour packages.

- Original passport with 6-month validity beyond your actual travel date & four blank pages in passport required which may vary depending on the consulate requirement.
- Visa granting is the sole discretion of the concerned Embassy or Consulate. Visa fees and other expenses like advance for hotel booking and ticket charges are not refundable, if the visa is rejected or delayed. In case the candidates are called for Personal interview, the candidates are required to attend the same before the concerned consulate at their own cost.
- If the customer doesn't agree to pay TCS/GST/Balance payment, it will be treated as cancellation under the policy of Sky Days Tours and Travels Pvt Ltd and no refund will be given.
- Visa copy is always sent to Guest on email by Sky Days Tours and Travels Pvt Ltd whereas sometimes Consulates send passport directly to the Guest residence. In both cases, it is the responsibility of the Guest to check the visa sticker and verify that the personal details and visa validity are accurate. Due to a mistake, if the immigration office does not allow the Guest to leave or enter the country, then Sky Days Tours and Travels Pvt Ltd will not be responsible for any refund/losses/consequences.
- If any Guest decides to cancel the tour for any reason whatsoever, they shall immediately send an email to Sky Days Tours and Travels Pvt Ltd from their registered email ID.
- Sky Days Tours and Travels Pvt Ltd is not liable to give any details or bifurcation of the cancellation charge.
- If Sky Days Tours and Travels Pvt Ltd cancels any tour, they will not be liable to pay any interest on the tour amount paid by the Guest.
- Rejection of visa will lead to deemed cancellation and the booking will stand to cancel without any intimation or confirmation from the Guest.
- Visa rejection date will be considered as the date of cancellation and the cancellation charge will be applicable accordingly.
- Guest can re-apply by paying additional visa charges, however granting of visa is at the discretion of the respective Consulates and Sky Days Tours and Travels Pvt Ltd will not be responsible for the same.
- If the visa is not granted even the second time, the cancellation charge will be based on the date of the rejection of the second visa.
- If no intimation of visa (granted/rejected) is received from the respective Consulate/Embassy, then it is considered as deemed cancellation and cancellation charge will be applicable as stated herein-above.
- Sky Days Tours and Travels Pvt Ltd reserves the right to terminate the tour of any Guest while on the road if the Guest doesn't follow the group tour decorum or misbehaves with co-passengers/Tour Manager/Coach Captain/ Local citizens or creates nuisance etc.
Guest will have to make arrangements for their return travel on their own and no refund is applicable under such circumstance. In such a case no refund or compensation is applicable.
- If Guest discontinues/terminates the tour for any personal reason, it is termed as deemed cancellation and no refund will be applicable
- Sky Days Tours and Travels Pvt Ltd team will assist the Guest to book the required services, however, all expenses for the same will have to be paid by the Guest immediately in advance.
- Certain cancellation cases can be eligible for insurance claim however settlement of the claim is at the sole discretion of the Insurance Company and Sky Days Tours and Travels Pvt Ltd is not responsible for the same.
- In case of any incidence probe to an insurance claim, it is mandatory to intimate Insurance Company and Sky Days Tours and Travels Pvt Ltd within 24 hours of any such incident.
- Reservation could be made through mail, fax or phone clearly stating the services required: we take the undertaking process of these reservations and duly confirm the arrangements.
- While making payment of first instalment for booking it is inferred by Skydays Tours that the customer has gone through and accepted the booking terms & conditions pertaining to the referred travel with us.
- The booking person or the customer initiating payment is accepting the terms & conditions on behalf of all the co-travellers in his/her booking in this way for a family or friends booking
